

## **Hospice Niagara's 5 Car Draw Rules**

### **Tickets**

Tickets are \$25 each or 5 for \$100.  
All tickets in a 5-pack must contain the same information.

### **Draw Order**

The draw sequence will be as printed on the official ticket.

All valid tickets are eligible for all draws. After the winning ticket is drawn and recorded, it is then returned to the drum and is eligible for all subsequent draws. The drum will be spun 2 times in between each draw.
