

Gift of Stocks & Securities Donation Form Guidelines and Instructions

Thank you for choosing Hospice Niagara as the beneficiary of your generosity. Your gift assists us in fulfilling our charitable mission to provide compassionate end-of-life care, at no-cost, to individuals in Niagara with life-limiting progressive illnesses and support to their caregivers and families.

There are just 3 easy steps to donate stocks or securities to Hospice Niagara:

Step 1:

Please complete all sections of the stocks/securities donation form.

For privacy reasons, your broker cannot disclose your name to us, so we ask you to please complete the Donor Information section of the form to advise us of your plan to make a donation of stocks or securities.

Your advisor/broker will provide us with your CUISP number which serves as a transaction number in order to track your transfer.

Step 2:

This step is important because securities are transferred into Hospice Niagara's investment account anonymously, without your name listed. Notifying Hospice Niagara will help ensure that you receive your official receipt for income tax purposes and to make Hospice Niagara aware of your intention to donate stocks or securities.

Step 3:

Fax, deliver or send your completed donation form to:

Your broker/investment advisor who is responsible for initiating the actual transfer of securities.

Note:

Stocks/securities are considered legally transferred only when Hospice Niagara's custodial agent confirms delivery.

Your charitable tax receipt will be valued based on the price on the close of the day when the stocks/securities are legally transferred to:
